ATLANTIC CITY, N. J., June 14—Congressman J. Hampton Moore, Philadelphia, and Congressman John J. Gardner, of this district, have accepted invitations to attend the "Dollar Dinner" banquet which has been organized by the Business Men's League as a demonstration in favor of Federal aid to deepen the water on the Atlantic City inlet bar.
